Dr. Stefan Schmale (55) worked for more than eight years as commercial Managing Director at Paulaner Brauerei GmbH & Co. KG in Munich. His previous experience includes various financial management positions at VIAG AG Group, Creatogen AG and Schaeffler KG. At MEGGLE AG, he will be appointed CFO to the Management Board and will be responsible for Controlling, Finance and IT.
